

Information on Personal Data Processing

(information obligation towards the data subjects under the GDPR and on the basis of Act No. 18/2018 Coll., on Personal Data Protection and on amendments to certain Acts)

In connection with Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) and in connection to obligations under Act No. 18/2018 Coll., on Personal Data Protection and on amendments to certain Acts, we fulfil our information obligation regarding the processing of your personal data.

Who is the controller of your personal data?

Our company has a responsible person for the protection of personal data, who oversees the proper processing of your personal data. What purposes do we process your personal data for and what is the legal basis for its processing?

We may process your personal data without your consent for the purposes arising from the relevant Record of the data controller's processing activities, which may concern processing on the basis of the legitimate interest of the data controller or the fulfilment of a legal obligation. Further details on the purpose of the processing and the legal basis for the processing of your personal data can be provided upon your request sent to the responsible person.

Which entities have access to your personal data?

In order to ensure the proper functioning of our company, other entities may have access to your personal data. These include, in particular, our external software administrator, external hardware administrator, auditor, law firm, contracting party which the data are provided to for the performance of the contract, and so on. Details on which entities may have access to your personal data can be obtained upon your request sent to the responsible person.

How long will we keep your personal data?

We will keep your personal data for as long as it is mandatory under Act No. 395/2002 Coll., on Archives and Registrars, as amended.

Profiling and automated decision-making in processing your personal data

What rights do you have in connection with the processing of your personal data?

You have the following rights in connection with the processing of your personal data pursuant to Act No. 18/2018 Coll., on Personal Data Protection and on amendments to certain Acts:

- The right of access to your personal data pursuant to Article 21 of the said Act
- The right of correction of your personal data pursuant to Article 22 of the said Act
- The right of deletion of your personal data pursuant to Article 23 of the said Act
- The right of restriction of processing of your personal data pursuant to Article 24 of the said Act
- The right of portability of your personal data pursuant to Article 26 of the said Act
- The right to object to the processing of your personal data pursuant to Article 27 of the said Act
- The right to file a motion to initiate proceedings pursuant to Article 100 of the said Act
